5. ASAA report by Gary Matthews
 - Al Howard retiring as Region III rep.
 - State BB bid committee will have proposal at Nome ASAA meeting
 - 2009 State wrestling site to be determined
 - 2A State berths allocation to be determined
 - Music amateurism rule to be defined
 - Proposal to add tennis as sports for IDEA and Raven
 - Conference governance to be defined in by-laws
 - Proposal to combine Denali and Kachemak wrestling conferences

Don Kassube presented a request from the basketball officials proposing using 3-man officiating crews at AA State basketball tournaments. This would affect ONLY State games and not regular season and conference play. The officials feel that 3-man crews would provide better coverage on the floor and increase the pool of available officials. This will be a fall meeting agenda item for Region II and we will also ask about 3-man crews at A State basketball.

6. ASAA Board Report by Terry Martin
 - Infograms sent out by ASAA are very helpful and informative
 - Region II should consider holding a winter meeting
 - Wrestling proposal: State A/AA/AAA and AAAA separate or combined for championship (Saturday) round. Region II prefers separate venue.
 - Proposal to combine Denali and Kachemak wrestling conferences. Region II supports the combination of the two conferences.
 - Discussed proposal to allow 3 Russian schools to form a cooperative hockey team with 4A Homer High. Region II does not support this proposal.
 - Discussed rotation of State basketball with A/AA and AAA/AAAA alternating the Monday-Wednesday slot and the Thursday-Saturday slot. Region II is in favor of the concept but did recognize the financial risks involved.
 - Discussed the 2A berths to State with the 8 berths and 5 conferences
 - Discussed the music amateurism issue and proposal to have paid musicians donate revenue to schools to maintain status as an amateur
 - Discussed conference governance issues
 - Discussed 3-man referee crews at 2A State basketball
 - Discussed issues surrounding 8th grade eligibility for basketball at very small high schools
 - Susan B. English letter was read and presented to Terry Martin
 - Were informed of a possible cooperative school program with Nanwalek, Port Graham, and Susan B. English Schools in basketball for 2009-10
